Background and purpose – The PTSA invites Cascade Ridge teachers and staff members to apply for Education Grants for programs and projects that will enhance the educational experience of the students at Cascade Ridge. The Education Grants will be awarded pending approval by the PTSA Board monthly

Requirements - Education Grants must be used for educational purposes and will be awarded to teachers, teaching teams, and/or staff whose proposed use impacts the greatest number of students in the most effective way. Education Grants are to be used during the school year in which they are awarded.

Application Process - PTSA Education Grants may be awarded monthly during the school year while funds are still available. Grant applications will be accepted by the first Friday of each month.

Review - Your PTSA Grant Request must first be submitted to the school principal for approval. It will then be forwarded to the PTSA Board. You will be notified whether or not your application is approved within 2 weeks after receipt of application, sooner if possible. Applicant's Name:
